Instructions for candidates: -

1. The merit list will be valid for one year from the date of publication of the merit list.
2. The above merit list has been published as per the total marks of written examination and Interview secured by the candidates for post (1, 2, 3) and marks of Interview for Post (Sl. 4).
3. The selected candidates are instructed to report to the Office of the Project Officer cum District Welfare Officer, Backward Classes Welfare and Tribal Development, Balurghat, Dakshin Dinajpur for appointment against the vacancies by **29.05.2025**. If a candidate does not appear for appointment within **29.05.2025**, it will be assumed that he/she is unwilling to join the post and subsequently candidate from the waiting list as per merit will be offered appointment.
4. Even after issue of appointment, a candidate is found to be ineligible in terms of advertisement his/her candidature & appointment will be cancelled without further reference to him/her.
5. It is reiterated that these appointment will be made on purely contractual basis and the same will not be regularized by any means whatsoever.
